The Securities Analysts Award for Excellence in Corporate Disclosure is an award system in which securities analysts develop objective criteria for evaluating the quality, quantity, timing, and other aspects of a company's disclosure and has been conducted every year since 1995. Of the 300 companies in 18 different categories, Sekisui House was ranked No. 1 in the Construction / Housing / Real Estate out of 17 companies in that category for the reasons shown below.
